Worldwide preventive dental treatment	
Examinations	Up to £100 per policy year

NHS dental treatment	
NHS dental treatment	100% reimbursement for treatment carried out by an NHS dentist and charged at NHS rates in England, Scotland, Wales and Northern Ireland
Emergency and Injury treatment
