Denplan Dental Emergency and Injury Cover is an optional additional insurance product, provided by Simplyhealth Access, that you can add on to your Denplan Essentials payment plan for just 60p per person per month.

For just 60p per person per month, it provides:

- ✓ Temporary emergency dental treatment in the UK when you're more than 40 miles* away from your registered practice (up to £600 per incident. Maximum payable £1,200 each claiming year)
- ✓ Temporary emergency dental treatment when overseas (up to £600 per incident. Maximum amount payable £1,200 each claiming year)
- ✓ Up to £100 for each night you stay in hospital under the care of a dental or maxillofacial surgeon for dental treatment for up to one year
- ✓ Up to £12,500 towards one course of mouth cancer treatment for up to 18 months following diagnosis
- ✓ A one-off payment of £2,500 if you are diagnosed with mouth cancer

Denplan Dental Emergency and Injury Cover does not cover:

- ✗ Emergency dental treatment provided by your own dental practice or a dentist/specialist acting on your dental practice's behalf
- ✗ Dental injury caused while training for or participating in contact sports, unless appropriate mouth protection is worn
- ✗ Mouth cancer if you were diagnosed before or within 90 days of your start date or, are having investigations or waiting for the outcome of tests within those 90 days, even if the diagnosis is not made until later
- ✗ Mouth cancer situated in the tonsils

Please remember: Treatment is at the discretion of your practice team. This is a summary of some of the benefits, exclusions and limitations. All claims are assessed for eligibility against the terms and conditions of the policy, available on request.

*When you're within 40 miles of your registered Denplan provider you should speak to your practice regarding the emergency dental care agreements in place for you outside of normal surgery hours.
